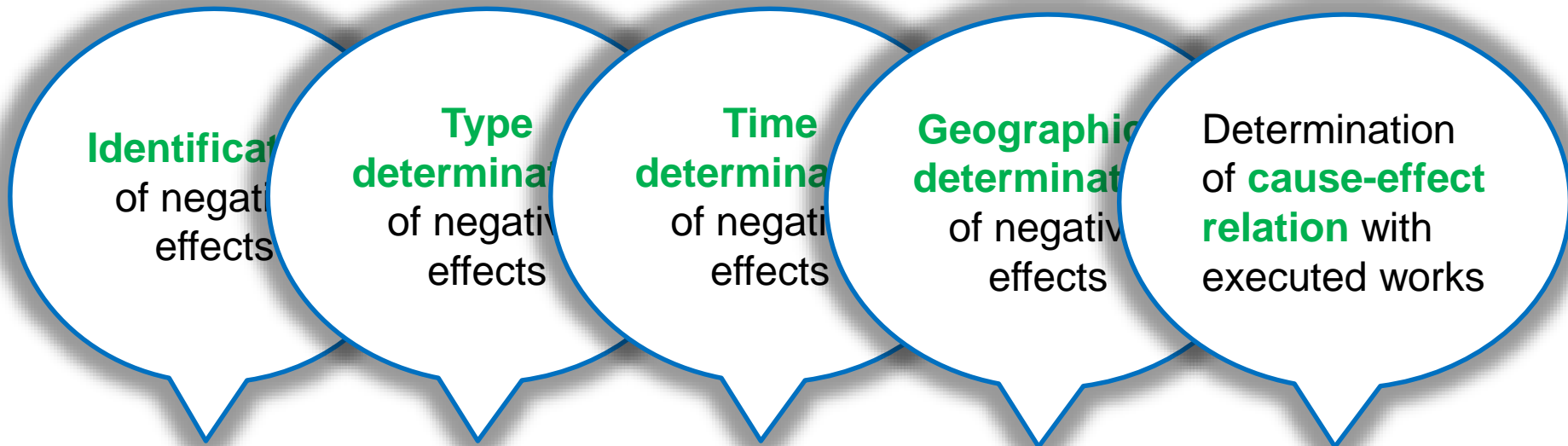

# Conditionality Principle



Proposal and Design phase upon the **fulfilment of elaborated conditions**

# Proposal & Design

✓ Proposal is made by the S&EMSC

✓ Proposal must contain:

**Type** of measure

**Geographical determination** of measure

**Time determination** of measure

Analysis of **effects** of measure

Analysis of **costs** of measure



✓ Proposal must be **approved by ER and FB**, before official **approval by the CA**

# Implementation

**Costs** for design and supporting activities are planned under the **(lump sum part of) S&EMSC budget**

**Costs** of implementation must not exceed the limit defined within the **provisional sum** under the WKSC

**Costs** for supervision of implementation are covered under the **(lump sum part of) S&EMSC budget**

Measures must be proposed, designed and implemented within the duration of **SEMCS and WKSC**

# Provisional theoretical compensation measures

- ✓ Intervention to ensure connectivity of water bodies within the river bed;
- ✓ Intervention related to the adjustment of the crest level of the existing structures;
- ✓ Intervention related to connectivity of waterbodies in floodplains;
- ✓ Re-naturalization of the site components;
- ✓ Activities related to parts of local habitats of endangered and protected species
