OUTCOMES

Mr. Mihajlovic, director of Plovput, opened the stakeholders' workshop, thanked all participants for showing interest in the NEWADA duo project and wished them a successful meeting.

Mr. Mitrovic, project manager of Plovput, proposed the up side down agenda and gave word to all participants, in order for the crucial issues related to the Danube navigation could be identified. All participants agreed on the changed agenda, and the live discussion started.

As a major topics related to inland navigation in Serbia, the following have been identified:

- Importance of the RIS system, and usage of the system by all skippers and port authorities
- Interaction with the ISRBC in certain areas, as fairway marking planning practice
- Importance of ship waste management for inland navigation on the Danube River
- Rising importance of the passenger transport
- Experiences of the container line transport on the Danube River
- Administrative and procedural problems
- Growing age structure of skippers
- Importance of staff in logistic companies
- Framework of the EU strategy for the Danube Region
- · Education of the staff related to inland navigation business
- Importance of obligatory legislation in inland navigation
- Importance of proper hydrological data and fairway condition forecasting
- Necessity of investments in fleet and port capacities.

After discussion, Ms. Keri and Mr. Polhorsky gave a short overview on the NEWADA duo project, Ms. Gilkarov explained the communication approach of Danube waterway administrations in the project, while Mr. Mitrovic responded to the issues identified by stakeholders pointing out how the NEWADA duo project can held the Danube waterway users in terms of provision of relevant data in the harmonized quality. Mr. Mitrovic explained the interaction with the CO-WANDA project as well. He pointed out that this was the first stakeholders' workshop where Danube waterway administration identified challenges and proposed some solutions. During the implementation of the project, a communication with stakeholders will be continued. At the end of the project, a final national workshop will be organized where Danube waterway administrations will explain what they did for the Danube waterway users within the NEWADA duo project.
